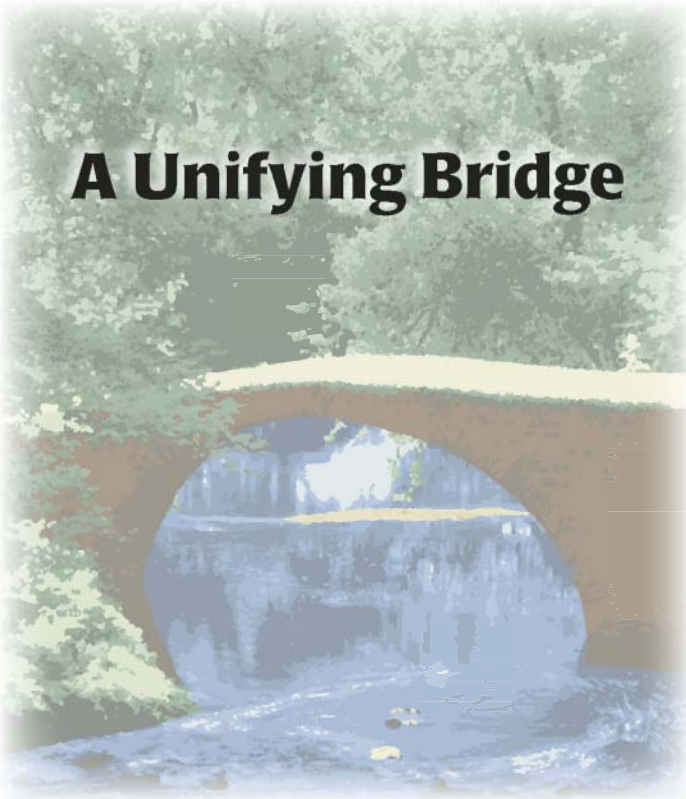


A Unifying Bridge
